- FAQ Booklet: Lauren will be getting printed asap.
- Van: Lauren called Outer Islands RCMP to discuss the van. The van has current insurance and is parked in an area without restrictions so it is legally allowed to be in that location. Kat will follow up with the CRD regarding parking in the "downtown" area.
- Welcome Signage: Contacted Todd Shannon, Operations Supervisor for CRD Parks, and was told that they will be putting a 3-sided kiosk for the new trail in the current staging area by the electrical poll. He is willing to work with the Chamber to see if a Welcome Sign, provided by the Chamber, could also go here. He would like to know a general size and design so that it could be worked into the current trail design. Discussion occurred regarding design, decided that would be good to investigate the route of a more traditional Welcome Signed done by an Indigenous artist. Kat will reach out to her Indigenous contacts to see if interest in providing design/sign. It would be ideal to have the Welcome Sign lower on the trail, Lauren will raise idea with Todd Shannon. While the pull off with current Mayne Island sign would be ideal

- the property is up for sale and lacks the potential permanency that the CRD location holds. Ideally, the map could be moved to the Miners Bay area.
- Bonfire: Would change the ratio of hot chocolate and cider, with more hot chocolate. Ideas for next year include: having a tear out sheet of lyrics in the Mayneliner as well as mugs from the Thrift Store for people who don't bring their own. Talked with Colleen of Alea and best idea at present would be to have a two page ad that could be cut out.
- Brochure: Need to start planning 2024 brochure

## New Business:

- Budget: Drew, Kat, and Lise will work on getting a budget together. Lauren will send Kat the AGM financial statements from the past 5 years.
- Chamber Matching Donations Campaign: Lise put together a MayneGives document with potential outline for how could do future matching donation campaigns. A budget is needed first to identify amounts possible. Could also send to Pender, Saturna, and Galiano to see if they want to join in. Lauren can send Lise's file to the other islands with the idea.

## Continuing Business:

- Networking Event: Still no liquor licence at Montrose, has been postponed until occupancy permit. If don't want to wait can pick different space. Estimate 1.5 months. End of Feb, beginning of March. Or change time of day so that alcohol isn't as expected.
- Press Tour: Reached out to local writer to work with Lise. Fall might be better time for lack of busy-ness. Will reach out to Cherrie Thiessen to see if interest. Look at doing one a year, with different themes.
- CBMF: Dates are posted. Board would like to see locals ticket pricing and brochures being handed out. Chamber would be willing to help fund bus again. Chamber to work with Anika to develop a one pager on potential Mayne puzzle/magnet/sticker idea that would be introduced at festival.
- BCIT App: Gord working on
- Arts Council Liaison: Nothing to report
- Welcome Sign Framing: Signs are framed and at the docks.
- Community Centre Update: Door is installed, a group of volunteers will be doing sidewalk. Funds from the Chamber are not needed.
- Roundtable Ideas: It is worth the Collective taking on a half to one hour long meeting where groups meet and do a 2 minute present on what they are doing, along the lines of what Selena had started. Would like to reach out to Pender, Galiano, and Saturna Chamber boards to come to Mayne and connect. Idea to reach out to island businesses to find out the best thing, and quirkiest thing about their business.
