4. Correspondence

- An email has been received from the CRA Outreach Office offering to do workshops/talks on island in areas including: Persons with Disabilities and the Disability Tax Credit, Seniors and Income Tax, Newcomers and Income Tax, Students and Income Tax, Benefits and Credits for Indigenous Peoples, and General information on Benefits and Credits. Kat felt that providing a workshop might help fulfill the community aspect of the Chamber's mission. After further discussion it was decided to bring up this issue at the AGM to see if there was interest from the membership in hosting a workshop.

Action Item: Lauren Underhill to put question of CRA workshop on AGM Agenda.

- A sponsorship request letter was received from the organizers of Tour Des Iles (see letter attached at end of minutes) seeking funds for the 2019 Tour Des Iles event. Funding was provided by the Chamber in 2018 and the event could be advantageous for merchants in Miners Bay, as well as others on the island if they cater to the event. It would be helpful if the organizers provided a postcard style information sheet on the event that could be handed out at businesses if customers have questions.

- An email was received from Elizabeth May's office regarding the draft Federal Sustainable Development Strategy for 2019-2022. This was forwarded to the board members for feedback.
- A letter regarding electric charging station funding from Elizabeth May's office was received. It was decided that this information should be sent to the membership. [Upon further investigation, when the information was going to be sent out, the application period had already closed, if a further period opens, information will be distributed.]

5. President's Report

- The Community Resource Centre is putting in a new office at the former Blue Heron Liquor Store at the Mayne Island Resort. They have hired a staff person for the centre and further information will be forthcoming.

- The CRD Letter of Support for Phase 1 of the Trail Project (from Village to Miners Bay) is done and will be signed/mailed off.
- There was not much response to the email send out requesting information for high-school students in regards to jobs or on-island businesses that might hire students.
- Roadtrippers.com did a story on apple orchards in the Southern Gulf Islands, including on Mayne Island. The writer (Diane Selkirk) was sponsored by the Chamber for the Mayne Island component of her journey. The article was well received, but didn't highlight many Chamber members.
- We need to have an official Vice-President for the Summary of Boards of Trade Act Form.

- A discussion about organization of the Chamber office at Studio 652 occurred.


